NOTIFICATION

No. **SORI(SGA&CD)2-30/2010**:- In exercise of the powers conferred by Section 26 of the Sindh Public Procurement Act, 2009, the Government of Sindh are pleased to make the following amendments in the Sindh Public Procurement Rules, 2010 :-

AMENDMENT

For rule-18, the following shall be substituted:-

“18. Response Time. The procuring agency shall give due consideration to the scope, magnitude and nature of procurement, while deciding the response time, which shall not be less than fifteen calendar days in case of National Competitive Bidding, and thirty calendar days in case of International Competitive Bidding:

Provided that in case of International Competitive Bidding, the head of Department may increase the response time by a further fifteen days (total 45 days), if he is of the opinion that thirty days may be insufficient for response by bidders:

Provided further that the Notice Inviting Tender (NIT) shall be hoisted on Authority's website in case of procurements upto rupees one million and published in newspapers in case of over rupees one million on or before the date of issuance of bidding documents”.
