**SUBJECT. RE-APPROPRIATION OF FUNDS BY FREEZING EQUIVALENT AMOUNT UNDER THE HEAD OF ACCOUNT "SC21108-GRANTS AND SUBVENTIONS" TO THE HEAD OF ACCOUNT OF RESPECTIVE ADMINISTRATIVE DEPARTMENTS.**

I am directed to refer to this department's Circular letter bearing No. FD/SR-II/11(900).2016 dated 27<sup>th</sup> July, 2016 and a notification bearing No. FD(SR-II)/HIC/11-1445/2015 dated 5<sup>th</sup> October, 2016, regarding an Amendment in the Sindh Civil Servants (Medical Attendant) Rules, 1993, thereby enhancing the limit / power to sanction funds on account of Medical Re-imbursment Charges upto Rs.150,000/- instead of Rs.5,000/-, as per existing policy, delegated to all Administrative Departments at their own level, subject to completion of codal formalities, to allow Re-imbursment of all kinds of expenditure on account of Indoor Medical Treatment to the Civil Servants from BS 01 to 22, issued under Office Memorandum bearing No. FD (SR-II) 11-7089/2013-14 dated 1<sup>st</sup> September, 2015.

2. Finance Department agrees to re-appropriate funds, by freezing equivalent amount Rs.114.000 million (Rupees One Hundred Fourteen Million) only, under the Head of Accounts "SC21108-Grants and Subventions-107101-Relief Measures-KQ0055-Grants to Others in Sindh-A05270-To Others-19 Grant-in-Aid for Medical Treatment", to the Head of Accounts of respective Administrative Departments under Object Code "A 01274 Medical Charges", for Re-imbursment of Medical Charges, as under:

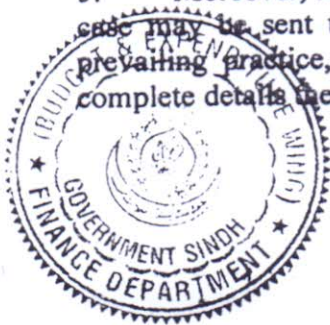

3. The Administrative Department will issue sanction of expenditure on account of Reimbursement of Medical Charges, **within the prescribed limit**, subject to proper examination, against the budgetary provision available in the respective Cost Centre, wherefrom the employee is drawing his / her salary.

4. In case of inadequate funds in the relevant Cost Centre, the Administrative Department may sanction expenditure from above re-appropriated funds, kept in the head of account of the respective Administrative Department and send an original copy of sanction order of expenditure to the relevant Section of the Budget and Expenditure Wing and Resource Wings, for re-appropriation and release of funds online in the relevant head of account, from where the employee is drawing salary.

5. Moreover, request for further additional funds under the respective Cost Centre, as the case may be sent to the Secretary to Government of Sindh, Finance Department, as per prevailing practice, if above re-appropriated funds are found inadequate, supported with complete details thereof.
