NOTIFICATION

No. RO(LG)/Misc./4(12)/2023: WHEREAS; in pursuance of Section 15 and 17 of the Sindh Local Government Act, 2013 (SLGA 2013), the Local Councils have been constituted and reconstituted in the province of Sindh.

And WHEREAS; in pursuance of Section 34 of the SLGA 2013, the Election Commission of Pakistan has conducted the Local Government Elections in respect of various categories/seats of Local Councils (LCs) and the returned candidates have accordingly taken oath of their office(s) in pursuance of Section 22 of the SLGA 2013.

And WHEREAS; consequent to coming into operation of the Local Councils in the province of Sindh, it has become expedient to distribute the Human Resources (HRs), Assets and Liabilities of the previous Councils among the newly created/reconstituted LCs for optimal utilization of available resources and to fully operationalize them.

Accordingly, the Local Government & Housing Town Planning Department, Government of Sindh (being the Administrative Department for LCs) had in pursuance of Section 155 of the SLGA 2013 notified the Transition Cell at Provincial Level, Divisional Transition Team (only for Karachi division) and District Transition Teams (DTT) for the rest of the districts in Sindh to formulate a plan for transition in a smooth and transparent manner besides ensuring fair distribution of the assets, liabilities and HRs.

And WHEREAS; based on the data collected, compiled and forwarded by the DTT district **Keamari** and after necessary scrutiny of the same, the PTC has recommended to LG&HTP Department vide Letter No: Member(Tech-I)/PLGC/2023/25 dated 31- August-2023 along with the minutes of the meeting of Provincial Transition Cell duly signed by all members for the approval of the District Transition Report in respect of Local Council(s) namely **Town Municipal Corporation Mirbahar, Town Municipal Corporation Maripur and Town Municipal Corporation Baldia**. The report has been duly signed by DTT and consists of bifurcation of HR, assets and liabilities.

Therefore, in view of the above, the Local Council and RDLG Karachi is directed to ensure the distribution of the HRs, Assets and Liabilities after due verification as enshrined in the attached Transition Report on immediate basis under intimation to PTC, DTT and this Department. The distribution of human resources is based on data provided by DTT and does not constitute an endorsement or the authenticity of appointments. That the responsibility for authenticity of the information provided to DTT rests with the Transition Officer, Chief Executive and Accounts Officer of concerned mother Local Council.

In case the newly constituted/re-constituted Local Council has any grievances with regard to the referred distribution, the same may be pointed out to PTC within a fortnight of issuance of this order. Upon issuance of this order concerned transition officer will cease to hold office.
